

### Legal Work


For the month of January to October we have facilitated the release of Two hundred eighteen(218) persons in detention.


### TOTAL NUMBER OF INTERVENTION





## MODE OF RELEASES




## AREA OF INTERVENTION




## RELEASE PER MONTH
