<p>From 261 barangay personnel trained by HLAf CRA in 2012, this number almost doubled in 2013 and totaled 384 including the new barangays. BCPC/CBRJ personnel are now equipped with knowledge, skills and attitude in handling cases of children and youth. They now have clear and defined tasks and some claims that despite their educational attainments, they now have confidence in performing their work effectively because of the trainings/workshops they have attended. Also, HLAf CRA's provision of training modules help the members in their daily work in the BCPC and some claimed to also practice and apply what they learned to their own children and other family members. One of the major gains of the training program is the paradigm shift from punitive to restorative justice in dealing with CICL. A group of Lupon staff in the barangay specifically barangays 168, 176 and 179 have shared their common experiences of conversion that changed their perspective in performing their function as mediator in the barangay. One of the realizations is the ability to understand the situation of the child and his background, the kind of family where he was raised and the kind of environment and the influence around him will enable the staff/mediator to respond to the needs of the child instead of thinking how to punish him for his wrongdoings. Restoring the lives and future of the children is very rewarding and made them feel more humane and good person. Their attitudes towards CICL has also changed "its not fair to judge them for what they did".</p>

<p>Based on the HIAF CRA PerMeter (Monitoring and Evaluation Tool), the first 5 Barangays have reached Level 2 with satisfactory ratings of 17-66%. Significant accomplishments of the barangays;</p> <p>a.1 Barangay 155 in Bagong Barrio has a strong support from their Punong Barangay Mercy Reyes and the Sangguniang Council. One of their strengths is resource generation that enabled them to fund special projects of BCPC for the children at risk in the barangay, the sportsfest participated by the children, networking with DOLE and TESDA to provide livelihood assistance to the families of the working children, and tapped organizations like the Caring Heart Fd. to support their programs on health and nutrition. Service delivery to the CICL and CAR has also improved maximizing the Menu of Interventions developed by the barangay. The BCPC/CBRJ members are consistent in fulfilling their tasks and responsibilities to carry-out the VMG of the barangay. Principles of Restorative Justice has a strong influence in the handling and managing of their CICL cases.</p> <p>a.2 Barangay 168 in Deparo has an active BCPC/CBRJ Champion, the barangay secretary Mr. Crizar Tuazon who had been consistent in promoting Child Protection and Juvenile Justice as one of the flagships of the present barangay administration. The barangay strategic plan which was formulated last year became the basis for the preparation of the Work and Financial Plan of the Barangay for 2014 duly approved by the Sangguniang Council including increase in BCPC budget. The BCPC/CBRJ members are working as a team where everybody is involved and conscious of their work assignments. As reported during the BCPC assessment, significant development and changes happened in the barangay as a result of the formation of BCPC and CBRJ such as- Awareness of the community about the existence of BCPC programs and activities, Manner of handling BCPC cases, CICL and CAR have changed drastically, and Number of CICL and CAR cases have decreased by about 30%. Barangay 168 has pioneered the formation of School Council for the Protection of Children in two schools particularly La Consolacion College in Deparo and Deparo High School backed with corresponding resolutions. The barangay has offered its facilities especially the conference hall for the series of trainings conducted by HIAF-CRA with new barangay on the last quarter of the year.</p> <p>a.3 Barangay 175 in Camarin Area A had struggled so much to sustain the interest of the BCPC/CBRJ members inspite of the lack of support from the Punong Barangay and some Kagawads. The BCPC members who are also under the Gender and Development Program of the barangay are trying their best to fulfill their responsibilities to ensure proper handling of CAR and CICL cases in the community. In spite of the political interplay, BCPC/CBRJ members were able to monitor the cases of children in the barangay and had launched the OPLAN GALUGAD [intensive monitoring of CAR and CICL]. Crime incidence has decreased and curfew of children was also intensified following the framework of child protection and child friendly hour. Service delivery has also improved through its 24/7 duty of the BCPC volunteers and barangay tanods.</p> <p>a.4 Barangay 176 in Bagong Silang was advanced from the other 4 barangays in terms of their experience in mobilizing the BCPC and the Committee on Child Justice and Welfare [same as CBRJ]. The BCPC had a strong supporter and ally from the former Punong Barangay Apolinario Trinidad and Kagawad Ruth Fradejas. The BCPC has a strong support in terms of their</p>			

Annual Budget, Menu of Interventions for both CAR and CICL, programs and services to all children in the barangay, and well trained staff and volunteers, the only barangay in Caloocan with professional social worker handling CAR and CICL cases. The BCPC committees were functioning very well, fulfilling their task and functions as well as mandates as the umbrella organization in the barangay who will orchestrate and consolidate the existing programs and services for the welfare of children.

The change in the administration specifically the Punong Barangay has brought chaos and displacement of BCPC staff and volunteers. Only three (3) from the existing staff were retained and the rest were assigned to other departments/units including the BCPC Coordinator. The PB did not adhere to the appeal of the BCPC staff and some kagawads, he appointed his own supporters because according to him people can be trained anyway to absorb the work of the incumbent staff. As per the last visit, HLAF staff introduced the CRA training package to train the new staff on BCPC and CBRJ Framework. One of the problems encountered by our staff is the retrieval of documents because as relayed by the old staff who were retained, the BCPC files were brought by the outgoing staff and volunteers, hence, cases handled during the last quarter were not properly monitored and recorded.

a.5 Barangay 179 in Amparo is blessed to have a Punong Barangay who championed the promotion of Children's Rights and Welfare in the barangay. The formation of BCPC and Restorative Justice Board for Children (same as CBRJ) paved the way for the improvement of policies and programs for children especially with CAR and CICL in the barangay. Functions of the BCPC and RJBC including the staff have been delineated resulting to efficient delivery of services to the children and their families. Both the offenders and the victims are now managed and handled by the BCPC/RJBC addressing their particular needs and concerns. The barangay had invested in training the staff particularly on Case Management for Para-Social Worker, Counselling Techniques for the Para-Counsellors, and Legal Procedures for Para-legal volunteers where they shouldered 90% of the required budget. The barangay has been consistent in following their thrusts as formulated in the Barangay Strategic Plan and the preparation of Annual Work and Financial Plan where budget has been increased. Transparency in the disbursement of their budget and proper allocation of budget according to priorities is one of the strenghts of the barangay.

The new barangays specifically Barangays 156, 178, 182, 184 and 185 have completed the training modules offered by HLAF-CRA inspite of the hectic schedules. The barangay staff were enthusiastic and committed to finish the training modules because the knowledge and skills acquired has been applied right away like in the case of Barangay 178, 182 and 185 where cases of children involved in minor crimes has increased at the onset of Christmas season. Case management has been improved especially now that the BCPC/CBRJ are directly involved unlike before that they will just endorse the case to the LSWDO covering their area and district and would wait for their further instruction to implement the necessary interventions.

The training modules have benefitted the new set of barangay officials from the Punong Barangay to the members of the Sangguniang Council. The BCPC orientation made the PB aware of the composition of the BCPC and CBRJ, the formulation of their Barangay Strategic Plan where Annual Work and Financial Plan has to be based, and the writeshop on Ordinance Formulation was appreciated very much by the barangay kagawads. As mentioned majority of the ordinance formulated has addressed the need to back up the creation and formation of BCPC/CBRJ with a resolution and it was very timely since they

are just starting their term in the barangay. As per last visit, they were all excited to draft the organizational chart of the BCPC/CBRJ, finalize the Menu of Interventions, set-up separate interviewing room for counselling, arrange files of cases separating records of CICT, and finalize the Child Protection Policy for approval of the council. If they will be rated the barangays will fall under level 2 with a score of 1-16%.
